BEFORE SUBMITTING, PLEASE INCLUDE:

- An invoice for the qualified system, showing the date of purchase, date of installation, manufacturer name, model and serial number.
- A Consortium for Energy Efficiency (CEE) or Air-Conditioning, Heating, and Refrigeration Institute (AHRI) Certificate for the qualified system, available at ceedirectory.org or ahridirectory.org, and enter the certificate number in the table below.

To be eligible for an HVAC/HP rebate:

- The customer must be a current PNM residential customer who is replacing an existing refrigerated air system with a more efficient, qualifying cooling system.
- A PNM Home Energy Checkup is required prior to a qualified HVAC/HP purchase or if you have had a Home Energy Checkup in the last 10 years.
- Qualified HVAC units must be installed within the PNM service territory and at the address where the PNM Home Energy Checkup was completed.
- Completed cooling rebate form must be submitted within six (6) months of the purchase of the qualifying HVAC/HP unit(s).
- Qualified HVAC/HP units must be installed by a licensed Heating, Ventilation and Air Conditioning PNM Home Energy Checkup Trade Ally. For a complete list, visit pnmhomecheckup.com/additional.

*The PNM Home Energy Checkup cooling rebate is based on the efficiency of the entire system, and not just the Seasonal Energy Efficiency Ratio (SEER) rating of the air conditioner or heat pump itself.

Air conditioners and heat pumps that are rated SEER 14, 15, 16, 18 or even 22 by a manufacturer can vary in efficiency, depending on the other equipment used in the system. Typical system components include the air conditioner/heat pump, indoor coil and furnace/air handler. With a higher SEER rating, you generally get more built-in upgrades, advanced technology and a longer warranty. Similar to how a higher-miles-per-gallon rating results in fewer fill-ups for your vehicle, a higher SEER-rated HVAC system will result in your dollars going further to cool your home. Installing a new, matched air conditioning system in your home can save you up to 20% to 50% on your cooling costs, depending on the efficiency of the system. **Having an SEER 18 air conditioner that is not part of a matched system installed in your home could result in a system that operates at SEER 13 or less.**
